At the onset, the undersigned would like to acknowledge you regarding the ongoing Government works in Karior Irrigation Scheme under Purulia Irrigation Division. It has once again come to information of the undersigned in writing by the Junior Engineer, Karior Irrigation Scheme that one miscreant named, "Laxmipada Mahato, C/O: Late Sambhu Mahato, Vill: Baragata, P.O: Mahatomara, P.S: Jhalda, Dist: Purulia" has recently on 9th November 2019 cut the inspection path on left embankment of LBMC at approximately 50m from the off-taking point & 70m approximately from the off-taking point of LBMC on the dam-dyke portion, in the eastern side of the schematic view attached along with this correspondence. L.A.P details depicting the possession & extent of departmental land has also been attached along with this correspondence for your ready reference.

Similar incident earlier was also intimated to you vide reference mentioned above but with utmost dismay the undersigned would like to inform you that till date no fruitful action has been obtained from your end.

Thus, the undersigned would like to request you to kindly take some suitable steps in the regard of growing menace of the miscreants to safeguard the staffs of Karior Irrigation Scheme from the fear of deteriorating law and order situation.
