The complainant above named begs to state as follows :-

1. That the Complainant is a resident of Tulin, within P. S. Jhalda and under the jurisdiction of this Court.

The accused persons are also residents of the same village.
2.

2. That Accused No. 1 is the husband of Accused No. 2. Accused No. 1 is the maternal uncle of the Complainant.

3. That the Accused persons are harbouring grudge and animosity against the Complainant and his family members. Mother of the Complainant has purchased property from her Boudi (Elder brother's wife) and her sons for which the Accused persons bore grudge against the Complainant and his family members.

4. That on the date of occurrence i.e. on 11.10.2019 when the Complainant and his wife and parents were in the house at that time the Accused persons came near the door of the Complainant and began to abuse the Complainant, his wife and his parents in gutter and slang language.

5. That the Wife of the Complainant Smt. Champa Dey came out from the house and requested the Accused persons not to abuse them in slang language and tried to

forbade them from using such remark and requested them to go to their house. Accused sadhan Dan had an Iron rod in his hand and Accused Jharna had a big stone in her hand

6. That when Smt. Champa Dey was requesting the Accused persons to cool down and not to abuse in slang language, the Accused persons became enraged and sadhan Dan with the rod in his hand assaulted Smt. Champa Dey on her head with force and Accused Jharna Dan with the stone in her hand assaulted Smt. Champa Dey on her face and nose. Accused No. 1 openly stated that he will finish the life of Champa Dey and her husband and with that intention and motive the said sadhan Dan assaulted Witness No. 2 on her head with the Iron rod. He again attempted to strike Champa Dey aiming towards her head but witness No. 2 any how saved her life and and fell down on the ground.

7. That when the Accused persons were assaulting Champa Dey she was crying and on hearing the same the Complainant and his parents and other persons come out from their houses and saw the incident. The Accused persons thereafter fled away..

8. That Witness No.2, Champa Dey sustained bleeding injury on her head scalp, nose and throat. The Complainant

Immediately took his wife to the I.C. Jhanda with the help of Motor Cycle. The Police Officer immediately referred the injured to Jhalda B.P.H.C. As the condition of Champa Dey was serious for which she was referred to Purulia Sadar Hospital for better treatment. At Purulia Sadar Hospital C.S. Scan was done and X-ray over nose and throat also done. Witness No. 2 was groaning with pain. Still Witness No. 2 has not recovered and she is facing lot of difficulties in moving and doing any work.

9. That the accused persons for the purpose of finish the life of Witness No. 2, assaulted her.

10. That information was lodged at Jhalda I.O. but as no action was taken, so information was also lodged before the Superintendent of Purulia on 6.11.2019. The condition of the injured person is serious and grave.

11. That search and seizure are involve and Medical report are either lying with the Police or are lying with the Doctor. The Police has not taken ^{any} action against the Accused persons and the accused persons are roaming in the Village as no action was taken against them.

12. That the Complainant is a poor person and he is not

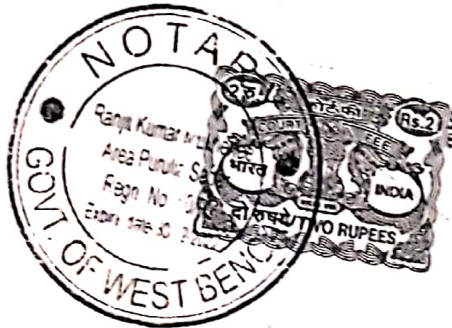
