

 The accused persons are also residents of the same village.

- 2. That Accused No. 1 is the husband of Accused No. 2. Accused No. 1 is the maternal uncle of the Complainant.
- 3. That the Accused pre persons are harbouring grudge and animosity against the Complainant and his family members. Mother of the Complainant has purchased property from her Boudi (Elder brother's wife) and her sons for which the Accused persons bore grudge against the Complainant and his family members.
- 4. That on the date of occurance i.e. on 11.10.2019 when the Complainant and his wife and parents were in the house at that time the Accused persons came near the door of the Complainant and began to abuse the Complainant. his wife and his parents in gutter and slang language.
- 5. That the Wife of the Complainant Smt. Champa Dey come out from the house and requested them Accused persons not to abuse them in slang language and tried to

to go to their house. Accused Sadhan Dan had an Iron rod

Scan was done and X-ray over mose and threat also done. Witness No. 2 was groaning with pain. Still Witness No. 2 has not recovered and she is facing lot of difficients in moving and doing any work.

- 9. That the accused perons for the purpose of finish the life of Witness No.2, assaulted her.
- 10. That information was lodged at Jhalda I.O but as no action was taken, so information was also lodged before the superintendent of Purulia on 6.11.2019. The condition of the injured person is serious and grave.
- 11. That search and seizure are involve and Medical report are either lying with the Police or are lying with the Doctor. The Police has not taken action against the Accused persons and the accused persons are roaming in the Village has no action was taken against them.
