The complainant above named begs to state as follows :-

1. That the complainant and the accd. person are the residents of vill-Metyala , p.s Jhalda dist- Purulia and within the jurisdiction of this Ld. court.
2. That the land bearing R.S. plot no 978 area 22 dec. of mouza- Metyala under p.s Jhalda , ~~presently~~ previously belonged to Gourinath Mahato exclusive possession over the said plot , he sold the same to Ananta Mahato , the grand father of the complt. by a Regd. sale deed dt : 10/5/1970 and he delivered possession to said vendee, After purchase Ananta Mahato came into possession over the same by growing and reaping paddy therein . There after said Ananta Mahato died leaving behind his only son namely Mohan Mahato as his heir, The said Mohan Mahato inherited

the above land and he came into possession over the same by harvesting paddy therein. While said Mohan Mahato was in exclusive possession over the aforesid plot he died leaving his son Gural Mahato, the complainant as his heir and legal representatives. So the complt. is the rightful owner and possessor of the afoesid land. The accd. person have got no vix valid right, title, intrest or possession over the aforesaid land/ plot.

3. That like previous year, this year also the complt. transplanted paddy over the aforesaid land/ plot in the 1st week of August 2019.

4. That on the date of occurrence i.e on 17/08/2019 at about 12/22.30 P.M. all the Accd. person named above being armed with deadly weapon Lathi, Tangi etc forming unlawfully assembly forcibly and illegally entered in the above plot of the complt. and they stated to uproot and damaged the paddy of the complt. There after the accd. no 3 Hemanta Mahato damaged the entire paddy with the help of Tractor. Hearing the above illegal activities of the Accd. persons the witnesses no 2 to 4 informed the matter to the complt over Telephone and after hearing the complt. came to the spot and he protested against the

illegal activities of the persons, the all the Accd. persons assaulted the complt. by fist and blow. The accd. p persons have damaged the entire paddy of the complaint stands over the aforesaid plot. The complt. sustained loss of Rs 7,000/-

The witnesses named above saw the incident and the matter was also reported to him.

5. That the complt. reported the matter to the o/c Jhalda p.s on 19/08/2019 by post and he also reported matter to the S.P. Purulia, but police did not take any steps against the accd. persons till today. The accd. persons are still now threading to the complt. in a divee consequence.

6. That the complt. is a poor man and he has got no capacity to file this case as a complaint basis case, so for the ends of justice police case is required.

It is therefore prayed that your honour may be graciously pleased to sent the petition of complainant the o/c Jhalda P.S. treating the same as F.I.R. and to investigate the same as provided u/s 156(3) cr.p.c accordingly.
