Sir,

In producing herewith the arrested accused persons namely (1) Ranjit Sahis (27 yrs) S/o-Shakti Sahis of Vill-Adrakuri, PS-Chandankiyari, Dist-Bokaro (JH) (2) Anadi Sahis (29 yrs) S/o-Late Senpati Shis of Vill-Bartard, PS-Joypur, Dist-Purulia under arrest along with seized articles as per seizer list i.e. 18 (Eighteen) bottles Illicit country spirit "DILKHUSH" (strength 80 up measuring 600 ML each bottles of Rs. 35/- out of which one bottle taken as sample & 10 pieces of plastic glass under proper seizure with label.

I SI Abhijit Singha of Joypur PS here by lodged a written complaint against the above noted arrested accused persons to the effect that on today (24/11/2019) at about 19:05 hrs when myself along with JC/-636 Dinesh Duley, JC/-282 Amit Ghosh were performed special mobile duty, as per my source information I reached at Tanasi more under Joypur PS and found that the above noted accused persons are selling country spirit "DILKHUSH" in the open places of Tanashi more. On seeing Police persons they conceal their presence at that place, but on searching we able to trace out them and also to found that 18 (Eighteen) bottles of Illicit country spirit "DILKHUSH" which were kept conceal in a bag in place. On being asked they disclosed their name and address as noted above. On interrogation they stated that they were selling Illicit country spirit liquor to the local people from the Tanasi more after collecting from other side but on demand they failed to produce any valid documents in respect of selling such illicit country sprit liquor. So it is reasonable to believe that they were selling the Id liquor illegally without any documents. So I seized the same under proper seizure list & label duly signed by them and other available witness after taking 01 bottle of DILKHUSH as sample out of 18 bottles of DILKHUSH. During further interrogation they confessed their guilt as such I arrested them today 24/11/2019 at 19:25 hrs as the accused persons are liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused persons (1) Ranjit Sahis (27 yrs) S/o-Shakti Sahis of Vill-Adrakuri, PS-Chandankiyari, Dist-Bokaro (JH) (2) Anadi Sahis (29 yrs) S/o-Late Senpati Shis of Vill-Bartard, PS-Joypur, Dist-Purulia u/s-46A (c) of the Bengal Excise Act 1909.
