On 13.11.2019 at about 01.35 P.M . I Sri Nilanjan Kumar Mondal, AE & Station Manager, Joypur CCC along with 01.Ganesh Mahato,Gr1 TSH,Joypur CCC,02.Sristidhar Mahato,HG.TSH,Joypur CCC, entered the premises of Sudhir Soren, S/O-Lt.Hakim Soren of village-Simultard P.S- Joypur , Dist- Purulia and found Sudhir Soren, S/O-Lt.Hakim Soren was enjoying electricity unauthorizedly drawing power from the LTOH line of WBSSEDCL through Al cable Red and Black colour by means direct hooking to his house premises and connected load found 1.033 KW. As Sudhir Soren, S/O-Lt.Hakim Soren, committed theft of electric power.So, I seized the following articles after preparing the seizer list in presence of 01.Ganesh Mahato,Gr1 TSH,Joypur CCC,02.Sristidhar Mahato,HG.TSH,Joypur CCC. The inspection team left the premises at 02.00 P.M.
