Chandra Sahis all of Village's Mohandih PS-Kenda, Dist-Purulia, When our staff were working departmental work on public interest.

On dated 06.11.2019 at about 02.30 PM our on duty staffs Sri Santu Dhali, SAE Manbazar CCC while working with technical team at village Mohandih some miscreants of villagers led by Sri Rahul Das S/O- Tapan Das, Shyamapada Mahato S/O- Binod Bihari Mahato & Bardhaman Sahis S/O- Lt. Chandra Sahis assaulted physically as well as mentally and also detained till 00.30AM dated 07.11.19. They also give obstruct to drink water and sit also.

Considering the above facts and circumstances you are requested to take appropriate legal action and taking it as FIR.
