In producing herewith the 02(two) arrested accused persons namely (1) Sk. Estfar (37 Yrs) S/O- Sk. Chutubabu (2) Siddik Khan (46 Yrs) S/o-Lt. Nawsad Khan both of Vill-Bagandih, PS-Jhalda, Dist-Purulia, along with two Trucks out of them one is 709E(Turbo) vehicle having bearing registration No-WB 37B/6357 & another is 407 Vehicle bearing registration No-WB 55A/2177 loaded with total Twenty (20) Bullocks and cows out of which bullocks are - 17 and cows are -03(colours of Bullock & cow mentioned in seizure list). I SI Muktipada Ghosh of Kotshila PS lodged a complaint against the above noted accused persons to the effect that on 17.11.19 at 17:05 hrs received a source information from my reliable source that two trucks mentioned above was coming from Jhalda side towards Kotshila through Ranchi-Purulia road having loaded with Cows.

This information communicated to O/C Kotshila PS and as per his direction, I SI Muktipada Ghosh and force namely C/138 Bani Bandopadhyay and C/424 Naba Kr.Sao left PS to work out the source information vide GDE No-603, Dtd-17.11.19. & C.C No-3132/19 Dtd-17.11.19. We reached at near Dangal more Naturn bandh on Ranchi - Purulia road with my source at about 17:45 hrs and watching for the above mentioned vehicles (Trucks). After waiting 5/7 minutes, on suspected ground we intercepted two Trucks out of them one is 709E(Turbo) vehicle having bearing registration No-WB 37B/6357 & another is 407 Vehicle bearing registration No-WB 55A/2177 which were coming from Jhalda side, but 02 (two) truck drivers were anyhow managed to fled away on seeing the Police party. On searching we found 12(Twelve) cows in truck no- WB 37B/6357 out of which 02(Two) cows and 10 (Ten) Bullocks and 08(Eight) cows in Truck No - WB 55A/2177 out of which 01(One) cow and 07 (Seven) bullocks are loaded in the trucks and was carrying in cruel manner within a short space of the vehicles. I also verified the source information and found that it was correct information about the above mentioned vehicles. I asked them to produced the relevant documents in respect of the Cows and as well as live stocks permit but they failed to produced any valid documents in respect of the Cows and as well as live stocks permit. During interrogation they also clearly confessed that they as per command and connivance of the owners of the vehicle having no- WB 37B/6357 & WB 55A/2177 namely Sk. Wahab of village Bagandih, PS- Jhalda, Dist- Purulia & Sk. Asiruddin of village-Hussandih, PS- Jhalda, Dist- Purulia respectively and few others namely Sk. Hasmat S/O-Sk. Chutubabu of village Hussandih, PS- Jhalda, Dist-Purulia, and Sk. Sabbir S/O Sk. Chutubabu of village-Bagandih, PS- Jhalda, Dist- Purulia, and others habitually deal with the business of stolen Cows & Bullocks without live stocks permit and assisting in concealment and disposing voluntarily of stolen cows in a clandestine manner since years. I recovered 20 (Twenty) Cows from the accused persons and seized 02 (Two) offending Trucks having no- WB 37B/6357 & WB 55A/2177 loaded with 20 (Twenty) Cows & Bullocks after preparing proper seizure list duly signed by accused persons and accompanied Police persons because of unavailability of the local people.

So, Larrested accused persons namely (1) Sk. Estfar (37 Yrs) S/O- Sk. Chutubabu (2) Siddik Khan (46 Yrs) S/o-Lt. Nawsad Khan both of Vill-Bagandih, PS-Jhalda, Dist-Purulia, after explaining ground of arrest and observing all formalities regarding arrest and brought to PS along with Two Trucks loaded with 20 (Twenty) Cows & bullock (As per Seizure list). Therefore I request that a specific case may kindly be registered against the accused persons namely (1) Sk. Estfar (37 Yrs) S/O- Sk. Chutubabu (2) Siddik Khan (46 Yrs) S/o-Lt. Nawsad Khan both of Vill-Bagandih, PS-Jhalda, Dist-Purulia (3). Owner of the vehicle No- WB 37B/6357, Sk. Wahab of village Bagandih, PS- Jhalda, Dist-Purulia (4) Owner of the vehicle No - WB 55A/2177, Sk. Asiruddin of village-Hussandih, PS- Jhalda, Dist- Purulia (5) Driver of the vehicle No- WB 37B/6357 (6) Driver of the vehicle No - WB 55A/2177 (7) Sk. Hasmat S/O-Sk.
