I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that Nakul Besra, S/O-Narayan Besra of village-Damrugutu, P.S- Kotshila, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 19.11.2019 at about 12.20 P.M. I Sri Nilanjan Kumar Mondal, AE & Station Manager, Joypur CCC along with 01.Ganesh Mahato, Gr1 TSH, Joypur CCC, 02. Shibaram Mahato, HG.TSH, Joypur CCC, entered the premises of Nakul Besra, S/O-Narayan Besra of village-Damrugutu, P.S- Kotshila, Dist- Purulia and found Nakul Besra, S/O-Narayan Besra was enjoying electricity unauthorizedly drawing power from the LTOH line of WBSEDCL through Cu cable red & black colour by means direct hooking to his house premises and connected load found 0.1 KW. As Nakul Besra, S/O-Narayan Besra, committed theft of electric power. So, I seized the following articles after preparing the seizer list in presence of 01.Ganesh Mahato, Gr1 TSH, Joypur CCC, 02. Shibaram Mahato, HG.TSH, Joypur CCC. The inspection team left the premises at 12.50 P.M.
