Entered the premises of Abdul Salam, Sl0-SK. Mutuk of Village: Namodiga Ps. Neturia Dist. Purulia and inspected his/her premises. During inspection theft of electricity was detected i.e. he/she was using electricity dishonestly by drawing illegal hooking from nearest LTOH line of WBSEDCL i.e. u/s 135 (1)(a) was detected.

From the above arrangement he/she was using the following electrical equipments:-

1. Electric Bulb - 01 nos (100 watt)
2. Electric Fan - 01 nos (80 watt)

1. Two core PVC cable with two nos hooking device of length 12 ft approx.
