I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri PANKAJ MANDAL (Present User) S/O- Atul Chandra Mandal of Village- Baishyakuli, P.O- Para, P.S- Para, Dist-PURULIA has committed theft of Electricity U/S-135 of the Electricity (Amendment) Act-2007.

On dated 11/11/2019 at about 1.15 pm I, Sri Santanu Sinha, Station Manager Anara CCC Customer Care Centre, WBSEDCL along with,

Entered the premises of PANKAJ MANDAL, S.O. Atul Chandra Mandal of Village- Baishyakuli, P.O- Para, P.S- Para, Dist-Purulia and inspected his premises. Meter NO - L4602077, Con Id - 242015006

During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by Direct tapping from incoming service cable by using polymer cable

Supply i.e. U/S 135 was detected.

From the above system he/she was using the following Electrical equipments i.e.

- 1) Fan - 4 nos (320 watt) 2) LED- 7 nos (140 watt) 3) TV- 1 no (120 watt)
4) 100 watt bulb - 4 nos (400 watt) 5) 200 watt bulb - 1 no 6) Pump - 1 HP (746 W)

Out of which we seized the following:

- 1) 2 nos 100 watt bulb & 1 no 200 watt bulb
2) 1 no energy meter (single phase) - L4602077, 3) Polymer Cable - 6 m

The seizure list are prepared at the site and the accused person refuse to signed in the seizer list.

The inspection team left the above premises at about 1:30 pm on dated 11/11/2019. The accused person has committed an offence U/S-135(i) of the Electricity (Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per Rule.
