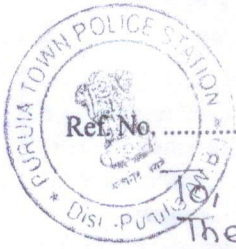

This morning, Rampada Mahata, a Hawker (News papers) at Purulia, was distributing Bengali News paper 'SURHABAR' for free as a part of marketing activity in front of St. Peter's School, Purulia from about 7 AM.

Mrs. Archita Sen, Principal of the School, directed of her staff to accost the Hawker who was then forcibly detained, despite his protests inside the school for about an 1 hour from 7.15am to 8.15am.

He was not given any reason for this unlawful detention and manhandling.

The Hawker was distributing the newspaper outside the school and had every right to do so. The act of the Principal cannot be justified.

Any newspaper is well within their right to distribute their newspapers, free or otherwise, in any public space.

I request action and support from your end in this regards.
