Sir,

I, SI Subrata Sarkar of Purulia (T) PS do hereby lodge complaint against (1) Usha Kumar w/o Joydeb Kumar of Garikhana, Ward No 18, Purulia, (2) Anuradha Kumar w/o Tapan Kumar of do, (3) Kaberi Chatterjee w/o Chandan Chatterjee of Reni Road, Purulia, (4) Usha @ Ishika Ojha of Karpur Bagan, Ward No 21, Purulia, (5) Nitu Viswakarma of Namopara, Purulia, (6) Binod Tewary of Anjir Bagan, Ward No 22, Purulia, (7) Sujata Khan w/o Soumitra Khan (MP, Bishnupur P.C.), Bishnupur, Bankura and approx 40 others, to the effect that on 18.11.2019 at about 12:00 hrs received an information at Purulia (T) PS that an unruly mob led by above persons have blocked the Purulia – Barakar road (SH 5) at Garikhana, Ward No 01, Purulia, for demanding to close a licensed wine shop cum bar there styled as “Shashi Vila”. The subject has been diarized at Purulia (T) PS vide Purulia (T) PS GDE No 771, dated 18.11.19 and as per direction of O/C, Purulia (T) PS, myself along with available officers and force including lady constables left PS for the Spot. Having reached at 12:15 hrs at the spot, it was observed that the unruly mob led by above persons has blocked the road. Then we the police party asked them to leave the place as they were doing illegal act by blocking the State Highway. Hearing that, those persons became furious and started shouting against police and obstructed the said road by sitting on the road under leadership of above persons and 40 others and had disrupted vehicular Traffic for some times. They were asked to clear the road, but they did not pay any heed to my word. Finding no alternative, I declared them as unlawful assembly and asked them to disperse from the place. After a long argument, they withdrew the blockade.

Therefore, I pray, that a specific case may kindly be started against the above accused persons and for arranging its investigation.
