With due respect and humble submission I beg to state that I am Shri Avijit Mukherjee (41) S/o Late Baidyanath Mukherjee of 277/05- Block Danga, Ward No-13, PS Raghunathpur, Dist-Purulia.

I beg to inform you that on 28/11/2019 at about 14:45 hrs while my brother namely Subhajit Mukherjee (D/B-12/01/1982) S/o Late Baidyanath Mukherjee of 277/05 Block Danga, Ward No-13, PS Raghunathpur, Dist-Purulia, who was an Assistant Sub-Inspector of Police, Bankura District Police Force, was returning to his house from Bankura Police Lines via Bankura-Saltora-Raghunathpur Road by his Motorcycle having Registration No. WB82C/1495 and when he reached near to Beldanga village under Raghunathpur PS one Truck having Registration No. JH10BV/1991 dashed his Motorcycle which was coming from opposite side.

As a result my brother received serious bleeding injury on his person and the Motorcycle also been damaged. Local Public immediately shifted him to Raghunathpur Super Specialty Hospital where he declared dead by the attending doctor. Over this started Raghunathpur PS UD Case No. 106/19 dated 28/11/2019. This only happened due to rush and negligent driving by the driver of the offending truck having Registration No. JH10BV/1991.

So, I therefore, pray before you kindly take necessary legal action against the driver of the offending truck having Registration No. JH10BV/1991 and also seized the said truck.

I was badly engaged for consolation to my family as such I failed to submit FIR in due time before your kind end.
