Entered the premises of Tarak Mandal, s/o - Saratan Mandal Vill. Aguibari P.S. Raghunathpur Dist- Purulia, having Consumer No. 242049388. Meter No. B3978872 and inspected his premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S 135(I)(b) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.
