Sub: Prayer for lodging FIR against accused Chotu Das (58) s/o Lt. Nakul Das of Ratanpur, PS-Santaldih Dist- Purulia U/S 46A (c) B.E. Act 1909.

Sir,

In producing herewith the arrested accused Chotu Das (58) s/o Lt. Nakul Das of Ratanpur, PS-Santaldih Dist- Purulia along with seizure - list and seized articles as described below, I beg to state that on 15.11.2019 at about 18.05 hrs I, SI Dipankar Biswas of Santaldih PS received a source information that huge quantity of country liquor /foreign liquor are stocked at the house of Chotu Das at Ratanpur for selling / transporting illegally without any valid license and matter is diarized vide Santaldih I.C. (BCW) GDE no. 151 and informed I.C. Santaldih PS. As per his direction I had been to village Ratanpur to work out the secret information of my source. Reached to the village at 18.55 hrs keeping distance from the alleged spot and conducted raid at the house of Chotu Das and found that i) 01 container approx 20 ltrs juice of Mahua with molasses, ii) 03 bottles liquor said to be "Mahula" and iii) 30 bottles 80UP country spirit (Dil Se) each bottles containing 600 ML country spirit are kept in a house. On being asked he failed to give any satisfactory reply and also failed to produce any valid documents for selling, stocking and transporting. Accordingly I seized i) 01 container approx 20 ltrs juice of Mahua with molasses, ii) 03 bottles liquor said to be "Mahula" and iii) 30 bottles 80UP country spirit (Dil Se) each bottles containing 600 ML under proper seizure list duly signed by the witnesses in between 19.15 hrs and 20.25 hrs. After observing all formalities I arrested Chotu Das (58) s/o Lt. Nakul Das of Ratanpur, PS-Santaldih Dist- Purulia under Bengal Excise Act and informed him the ground of arrest U/S 50 Cr.PC on 15/11/2019 at 20.35 hrs.

01 liter juice of Mahua with molasses, 01 bottle liquor said to be Mahula and 01 bottle Dilkhus are out from the seized articles as sample, labeled and sealed with sealing wax.

I, interrogated him about the purpose of the stocking and possessing of the above seized articles. He replied that it was the business of him. There is reasonable ground to believe that he has stocked for transporting and selling the above articles illegally and he committed offence U/S 46A (c) B.E. Act.

Therefore, I pray before you to start a case U/S 46A (c) B.E. Act. against the said accused Chotu Das (58) s/o Lt. Nakul Das of Ratanpur, PS-Santaldih Dist- Purulia.
