Sir,

In producing here with one arrested accused namely Kamal Mahato (43 Yrs) S/O Lt. Dubraj Mahato of Vill- Palashkola, PS-Adra, Dist- Purulia along with following seized articles with seizure list and Memo of Arrest.

1) 10 bottles (in sealed condition) DIL KHUSH country spirit, 600-ml each bottle, Rs-35 of each bottle.

I SI Subrata Sadhu of Adra PS do here by lodged a complaint against accused namely Kamal Mahato (43 Yrs) S/O Lt. Dubraj Mahato of Vill- Palashkola, PS-Adra, Dist- Purulia to the effect that on 10/12/19 at about 17:45 hrs in course of my special mobile duty I received a telephonic information from a reliable source that one Kamal Mahato (43 Yrs) S/O Lt. Dubraj Mahato of Vill- Palashkola, PS-Adra, Dist- Purulia has been stocked of country spirit illegally at his Shop at Palashkola village and selling the same to hike price for his personal gain. After getting such information I informed to my O/C and as per his direction I along with my accompanied force reached at Palashkola village at about 19:45 hrs. and hold raid in the shop of said Kamal Mahato and found that the said person selling liquor at his shop and after seeing the Police party some person fled away and said Kamal Mahato has try to concealed himself but I able to apprehend him with help of accompanied force and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produce any valid license or documents for possessing /selling the same. So it is sufficient reason to believe that said Kamal Mahato selling the country spirit by illegal way. I seized the above mentioned articles under proper seizure list duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest.

Hence I there for pray that a specific case may kindly be started against arrested accused Kamal Mahato (43 Yrs) S/O Lt. Dubraj Mahato of Vill- Palashkola, PS-Adra, Dist- Purulia under proper section of law.
