Sir,

In producing here with one arrested accused namely Ramesh Bauri (24 Yrs) S/O Bishnu Bauri of Vill- Sarberia, PS-Adra, Dist- Purulia along with following seized articles with seizure list and Memo of Arrest.

- 1) 12 bottles (in sealed condition) DIL SE country spirit, 375-ml each bottle, Rs-22 of each bottle.
- 2) Sale Proceed Rs/- 75
- 3) 09 (Nine) pieces of plastic glasses and 03 (Three) empty bottles styled as DIL SE.

I SI Sourav Banerjee S/O Sankar Banerjee of Adra PS do here by lodged a complaint against accused namely Ramesh Bauri (24 Yrs) S/O Bishnu Bauri of Vill- Sarberia, PS-Adra, Dist- Purulia to the effect that on 30/11/19 at about 20:25 hrs in course of my special mobile duty I received a telephonic information from a reliable source that one Ramesh Bauri (24 Yrs) S/O Bishnu Bauri of Vill- Sarberia, PS-Adra, Dist- Purulia has been stocked of country spirit illegally at his dwelling house / Shop at Sarberia and selling the same to hike price for his personal gain. After getting such information I informed to my O/C and as per his direction I along with my accompanied force reached at Sarberia at about 21:25 hrs and hold raid in the dwelling house/ Shop of said Ramesh Bauri and found that the said person selling liquor at his dwelling house/ Shop and after seeing the Police party some person fled away and said Ramesh Bauri has try to concealed himself but I able to apprehend him with help of accompanied force and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produce any valid license or documents for possessing /selling the same. So it is sufficient reason to believe that said Ramesh Bauri selling the country spirit by illegal way. I seized the above mentioned articles under proper seizure list duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest.

Hence I there for pray that a specific case may kindly be started against arrested accused Ramesh Bauri (24 Yrs) S/O Bishnu Bauri of Vill- Sarberia, PS-Adra, Dist- Purulia under proper section of law.
