



That on 9.07.2019 Rengali 23th Asarh 1426 B.S. Thursday at about 9.30 A.M. to 10.00 A.M. the complainant was working and plough with his brothers namely Chittaranjan Mahato, Satyapada Mahato both sons of late Ehadari Mahato in their big paddy land (Hir) being R.S. khatian No.461, R.S.Plot No.3612 as situated at mouza Rangamati within P.S.Arsha. In the mean time while the above named accused entered into the paddy land with a lathi and sharp, spade with his hand attempt to murder to the complainant and his both brothers namely Chittaranjan Mahato and Satyapada Mahato both s/o late Lhadari Mahato and he used to filthy languages to the complainant and his family members after that the complainant his brothers asked to accused with gently but he danied this speak, thereafter the accused persons hit by lathi complainant brother namely Satyapada Mahato s/o late Fhadari Mahato on his head and he fell down in the paddy land and the accused persons also hited again by again by this spade on his body as a result complainant's brother namely Satyapada Mahato s/o late Ehadari Mahato was grevious injury and sameless, when the complainant and his brother namely Chittaranjan Mahato tried to again save their brother namely Satyapada Mahato s/o late Hhadari Mahato but in this time that accused through the sharp spade and cut his left leg below the knee with bleeding and he


hited the complainant had by lathi and they were cried or save their life.

2. That the accused person illegally tresspossed

inhothe paddy land of the complainant with intention to finish them, the complainant and his brother raised halla and rushed to the place of occurence to save the complainant and his brothers on hearing the hulla and also the sound the other family members and villagers of locality reached on the spot of occurences and beeing coming to the side, the accused persons fled away saying and threatented that anybody who would spear against them would have the same fater also took away one silver chain from neck of the complainant's brother namely Satyapada Mahato s/o late Bhadari Mahato, due to happend the occurance previous much grudge.

- 3. That the above named P.Ws in the petition of the complainant reached the place of occurance and save the Complainant and his Brotherand and the witness are witnessesses this incident and complainant narrated the occurance.
- 4. That, after the occurance the complainant along with his injurial about the villagers went to police station Arsha, on that some day and narrated the entire incident, but concerned police did not instituted/registered any case against the above named accused personal nor visited the place of occurance so this complainant is filed in your Honour's court.





- 5. That the complainant and his brothers namely Satyapada Mahato s/o late Fhadari Mahato thereafter went to doctor in nearest hospital namely Sirkabad E.P.H.C.for their treatment as injuries were painful and serious in nature and the complainant and his brother Satyapada Mahato got the injuries treated in this hospital.
 - the complainant lodged a complain against the accused persons before the S.P.Purulia but police not registered any case against the accused persons, that the accused persons is a man of turbulent nature also gunda aliments to assault the complainant and his brother namely Satyapada Mahato s/o late Ehadari Mahato.
