Sir.

In producing here with one accused persons Surjya Kumar S/O Khokan Kumar (22Y)of Vill Satra . PS- Arsha. Dist- Purulia under arrest and the following seized articles under seizure list enclosed here with.

- (1) 15(fifteen) sealed plastic bottles (CS) containing 600ml each.
- (2) 10(ten) sealed plastic bottles (CS) containing 375 ml each.

I beg to submit that today on (23.12.19) in between 18:10 hrs to 18:55 hrs a raid was conducted at Mishirdih more in the shop of Surjya Kumar (22Y) S/O Khokan Kumar of Vill Satra, PS- Arsha, Dist- Purulia acting on a secret source information against illegal stocking and selling of liquor by the above noted accused person at the anticipated place and found that the above noted person was keeping/ selling liquor which was kept in his shop. On demand Surjya Kumar failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such, he committed offence U/S- 46A (C) BE Act and he was arrested under proper arrest memo. Also (1) 15 pcs. Sealed bottles of Dil Se country Spirit containing 600 ml each and (2) 10 pcs sealed bottle of Dil Se Country Spirit containing 375 ml each were seized under proper seizure list duly signed by witnesses U/S- 50 Cr.P.C and handed a copy of the same to arrestee.

The arrested accused namely Surjya Kumar (22Y) S/O Khokan Kumar of Vill Satra, PS- Arsha, Dist-Purulia committed offence U/S- 46A (C) B.E Act 1909 for unauthorized possession and sale of liquor.

It may be noted here that during raid 1. C/-970 Dolon Biswas of Arsha PS and C/-15 Santu Mondal of SAP 7th Bn camp at Arsha PS accompanied me.

Under the above facts and circumstances, I pray before you that a specific case may kindly be started against the said accused person under proper section of law and arrange for investigation.
