Sir,

This is to inform you that while patrolling I, Sri Ranjit Sing Sardar, Deputy Ranger/ Forester along with 1) Shahnawaz Faruk Ahmed, Forest Ranger 2) Lakhindar Bauri, Bungalow Chowkidar on 25/12/2019 at about 11-10 a.m. a tractor(Body Colour: Green & Yellow) with trolley(Without Number) was detected at the forest area of Hetjari mouza under Arsha P.S. & four unknown persons illegally engaged in excavating earth and loading in the trolley of the tractor. I approached to the tractor & asked the persons to show valid documents for excavating earth in the forest area.. They did not show any valid documents. After a few minutes Sri Kartick Kumar S/O:Gobinda Kumar Vill:Kumardih, P.O. Thakursima, P.S.- Arsha, Dist: Purulia along with about 20 Nos. other unknown miscreants appeared there & threatened us. We tried to seize the vehicle but they restrict us forcefully to execute Government duty & snatched the vehicle from us & fled away with the vehicle. At the time of seizure of the vehicle, Shahnawaz Faruk Ahmed, Forest Ranger was very much injured & hospitalized at Deben Mahato Sadar Hospital, Purulia because of their forceful restriction.

I, therefore, request you to investigate the matter & take necessary action..
