Jhalda and within the jurisdiction of this Court. Be it mentioned here that the ~~for~~ father-in-law's house of the complainant is at village Nowadih, P. S. Bagmundi District Purulia, i.e. in the village of the complainant.
- 2) That your petitioner used to work in the poultry Farm of the accused No.-1 at Name Para, Jhalda since for about six month prior to the date of occurrence on a fixed salary

of Rs. 10,000/- (Rupees Ten thousand) only per month.

- 3) That the accused no.-1 for the service by your petitioner paid Rs. 10,000/- (Rupees Ten thousand) only per month for two month but for the reasons best known to said accused has not paid any amount what-so-ever towards the salary of your petitioner.
- 4) That your accused no.-1 is duty bound to pay Rs. 40,000/- (Rupees forty thousand) for the salary for period of four months i.e. for May, 2019 to August, 2019.
- 5) That your petitioner requested several times for the said sum but the accused no.-1 avoided to pay the same on same pretext or other.
- 6) That lastly on 05/09/2019 the accused no.-1 told to your petitioner that he would pay the entire amount at his father-in-law's house at village Nowadih P. S.- Bagmundi, and asked your petitioner to meet there.
- 7) That accordingly your petitioner went to the house of the father-in-law of the accused no.-1 and requested to pay the salary amount.
