In producing herewith arrested accused person namely Bablu Orang (37 Yrs), S/O- Lt. Bhalu Orang of Vill- Suisa Colony, PS-Baghmundi, Dist Purulia along with seized articles,

I beg to report that on 23.12.19 during Mobile Duty, acting of secret source information and as per order of I/C Suisa OP myself along with force had been to Suisa Colony under Baghmundi PS at 16:35 hrs and as per indication conducted raid in the house of Bablu Orang (37 Yrs), S/O- Lt. Bhalu Orang of vill- Suisa Colony, PS-Baghmundi, Dist Purulia at 16:55 hrs and found 2/3 persons fled away from his house and detained one person on asking his identity he disclosed his name and addresses as noted above. On interrogation he confessed his guilty for selling and possession of ID liquor. On demand he failed to produce any valid document of selling of said ID liquor at his house. As such I seized 16 ltr. of ID Liquor and 03 Pcs. empty plastic glasses and 01 ltr. ID liquor as sample under proper seizer list in presence of witnesses and signed by the witnesses and accused person. Arrested the above noted accused person after informing him the ground of arrest and after observing all legal formalities. The sized articles were properly salad and labeled in presence of witnesses duly signed by them and accused person.

The above noted arrested accused namely Bablu Orang (37 Yrs), S/O- Lt. Bhalu Orang of vill- Suisa Colony, PS-Baghmundi, Dist Purulia committed offence U/S-46 A (c) of Bengal Excise Act 1909, for unauthorized possession and sales of ID Liquor at his house.
