I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Sri Debnarayan Singh Babu, S/O- Lalit Sambunath Singh Babu of village Pogrodih, P.O- Burda PS- Bagmudi, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 18/12/19 at about 1:30 P.M. I Sri Swapan Kumar Das, AE & Station Manager, Bagmudi CCC along with 1. Sri Sajal Kumar Mahanty, OFB 2. Sri Gurpratap Singh, Hh TSH, entered the premises of Sri Debnarayan Singh Babu, S/O- Lalit Sambunath Singh Babu of village Pogrodih, P.O- Burda, Dist- Purulia and found Sri Debnarayan Singh Babu was enjoying electricity unauthorizedly drawing power from the nearest LTOH line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.1 KVA. As Sri Debnarayan Singh Babu S/O- Lalit Sambunath Singh Babu committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Sajal Kumar Mahanty, OFB and 2. Sri Gurpratap Singh, Hh TSH. The inspection team left the premises at 1:40 P.M. Dt- 18.12.19
