I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Sri Buddheswar Singh Mure, S/O Sri Leli Bhutnath Singh Mure of village Pogrodi, P.O- Burda PS- Bagmundi, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 18/12/19 at about 1:45 P.M I Sri Swapan Kumar Das, AE & Station Manager, Bagmundi CCC along with 1. Sri Sajal Kumar Mahanty, OF 2. Sri Gurpratap Singh, HCH TSH entered the premises of Sri Buddheswar Singh Mure, S/O Leli-Bhutnath Singh Mure of village Pogrodi, P.O- Burda, Dist- Purulia and found Sri Buddheswar Singh Mure was enjoying electricity unauthorizedly drawing power from the nearest LTOH line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.1 KVA. As Sri Buddheswar Singh Mure S/O Sri Leli. Bhutnath Singh Mure committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Sajal Kumar Mahanty, OF 2. Sri Gurpratap Singh, HCH TSH The inspection team left the premises at 1:50 P.M Dt- 18/12/19
