I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Sri Indra Gope S/O- Sri Jaladhar Gope of village Pogrodih, P.O- Burde PS- Bagmundi, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 18/12/19 at about 11:55 P.M I Sri Swapan Kumar Das, AE & Station Manager, Baghmundi CCC along with 1. Sri Sajal Kumar Mahant, 08 2. Sri Gurpratap Singh, HCTS14, entered the premises of Sri Indra Gope, S/O- Sri Jaladhar Gope of village Pogrodih, P.O- Burde, Dist- Purulia and found Sri Indra Gope was enjoying electricity unauthorizedly drawing power from the nearest LTOH line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.1 KVA. As Sri Indra Gope S/O- Sri Jaladhar Gope committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Sajal Kumar Mahant, 08 and 2. Sri Gurpratap Singh, HCTS14. The inspection team left the premises at 2:00 P.M. DT- 18/12/19
