Respected Sir,

In producing here with one arrested accused person namely Gobardhan Rajwar (30 yrs) S/O- Jhyoti Rajwar of Vill- Telai, P.S.- Balarampur, Dist. Purulia along with seized approx 10 (ten) liters Country Sprit (ID liquor) with plastic Jarican and 08 pieces plastic glass. (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 17:15 hrs. I received a credible source information that one Gobardhan Rajwar (30 yrs) S/O- Jhyoti Rajwar of Vill- Telai, P.S.- Balarampur, Dist. Purulia is selling country sprit without any valid license from his own house at Telai village under Balarampur P.S., Dist.- Purulia. Accordingly, I inform to O/C Balarampur P.S. regarding this matter and as per order of O/C Balarampur P.S. I along with force left for Telai village to work out the source information. Thereafter we reached at Telai village at about 17:45 hrs as per source information and held raid in the house of Gobardhan Rajwar.

During search with the help of accompany with force, we found that the said person is selling country sprit in his own house. On demand, he failed to produce any valid documents or valid License in respect of selling and keeping of said country sprit. Accordingly, I seized the said country sprit (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labelled one bottle (600 ML) as a sample. I arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act 1909 after maintaining all the formalities as per NHRC guide line.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(C)B.E. Act against the arrested accused person namely Gobardhan Rajwar (30 yrs) S/O- Jhyoti Rajwar of Vill- Telai, P.S.- Balarampur, Dist. Purulia to start a cog case U/S 46A(C)B.E. Act and arrange for its investigation.
