Sub: Lodging F.I.R against Sri Abani Das, S/o. Lt. Gangadhar Das for unauthorized use of Electricity by way of hooking u/s 135(i)(a) of Electricity Act 2003 (Amended in 2007).

Sir,

I Sri Amitava Choudhury, S/O- Lt. Sajal Kr. Choudhury, D.E & Station Manager of Balarampur CCC of WBSEDCL do hereby lodge complaint against Sri Abani Das, S/o. Lt. Gangadhar Das resides at Vill-Hanspur, Po. Shalboni, PS: Balarampur, Dist. Purulia to the effect that received an information, that the aforesaid accused person is committing theft of Electricity in his residence by way of direct hooking from the LTOH Line of WBSEDCL.

Acting upon such information on 11.12.2019 from 4.45 PM to 5.20 PM I, along with Sri Manab Kr. Maji, S.A.E, Sri Arindam Chatterjee, O.E Balarampur CCC and technical persons of M/s. Ajoy Kr. Ghosh (Enlisted Agency of WBSEDCL) inspected the premises of Abani Das and held raid.

During raid and inspection it was detected that accused Abani Das is using electricity dishonestly by making direct hooking from the nearby LTOH Line of WBSEDCL for running 1 No. 100 Watt Lamp, 1 No. Ceiling Fan and 8 Nos. 9 Watt LED Lamp having connected load 0.232 KW. There exists one Service Connection of WBSEDCL bearing Consumer ID: 242213978 stands recorded in the name of the accused which was in disconnected condition due to nonpayment of energy bill.

I prepared Inspection report in presence of the representative of the Accused and assessed the Load as 0.232 Kw. Details have been mentioned in the Inspection Report duly signed by the representative of the accused.

I directed Sri Rajib Sahis, Supervisor of M/s. Ajoy Kr. Ghosh (Enlisted Agency of WBSEDCL) to disconnect the hooking line/ arrangement from our LTOH line. Accordingly they disconnected the aforesaid hooking line/arrangement from LTOH Line.

I prepared seizure list in presence of the representative of the accused & witnesses, details of seizure have been mentioned in the seizure list and obtained signature of the representative of the accused. A copy of the seizure list was handed over to the representative of the accused. The Local people gathered there witnessed the incident but refused to sign on the Seizure list and inspection report.

For this activity of theft the WBSEDCL has sustained huge financial loss in terms of revenue.

It is well evident that the abovementioned accused person has committed offence u/s 135(i)(a) of Electricity Act 2003 (Amended in 2007).

Kindly treat this complaint as FIR and take necessary action against the accused.
