Respected Sir,

In producing here with one arrested accused person namely Thakur Das Gope @ Kumbha Gope (31 yrs) S/O- Ramesh Gope of Vill.- Shyamnagar, P.S.- Balarampur, Dist. Purulia along with seized 09 (nine) sealed country sprit bottles (DIL Se) Each Bottle 600 ML (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 18:15 hrs. I received a credible source information that one Thakur Das Gope @ Kumbha Gope (31 yrs) S/O- Ramesh Gope of Vill.- Shyamnagar, P.S.- Balarampur, Dist. Purulia is selling country sprit without any valid license from his own grocery shop at Shyamnagar village under Balarampur P.S., Dist.-Purulia. Accordingly, I inform to O/C Balarampur P.S. regarding this matter and as per order of O/C Balarampur P.S. I along with force left for Shyamnagar village to work out the source information. Thereafter we reached at Shyamnagar village at about 18:35 hrs as per source information and held raid in the grocery Shop of Thakur Das Gope @ Kumbha Gope.

During search with the help of accompany with force, we found that the said person is selling country sprit bottles (DIL Se) in his own grocery shop. On demand, he failed to produce any valid documents or valid License in respect of selling and keeping of said country sprit. Accordingly, I seized all the sealed country sprit bottles (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labelled one bottle as a sample. Total 09 (nine) sealed country sprit bottles (DIL Se) Each Bottle 600 ML and arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act 1909 after maintaining all the formalities as per NHRC guide line.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(C) B.E. Act against the arrested accused person namely Thakur Das Gope @ Kumbha Gope (31 yrs) S/O- Ramesh Gope of Vill.- Shyamnagar, P.S.- Balarampur, Dist. Purulia to start a cog case U/S 46A(C)B.E. Act and arrange for its investigation.
