Subject: Complaint against Satya Mandi (55 Yrs), S/O- Late Jagran Mandi of Vill- Buribandh, PS - Boro, Dist - Purulia to start a case U/S- 46A(C) B.E. Act 1909.

Respected Sir,

In producing herewith one arrested accused person Satya Mandi (55 Yrs), S/O- Late Jagran Mandi of Vill- Buribandh, PS - Boro, Dist - Purulia with seizure of (1) approx 10 liters illicit spirit containing in 01 (One) ten liters white colored Zariken, (2) Rs. 55/- as sell proceed from the possession of above noted accused which were seized under proper seizure list.

I beg to submit that today (23.12.19) during my evening mobile duty in between 16:35 hrs to 17:05 hrs acting on a secret source information I apprehended the above noted person at Buribandh at his house and found that above noted person illegally stocked and selling I/D liquor to local public. On interrogation he disclosed his name and address as noted above. On demand he failed to produce any valid documents / License in respect of said illicit spirit which was kept in his house. Accordingly I seized 1) approx 10 liters illicit spirit containing in 01 (One) ten liters white colored Zariken, 2) Rs. 55/- as sell proceed under proper seizure list in presence of witnesses, u/s 67 A (C) B.E. Act which is enclosed herewith. As such he was arrested at 17:05 hrs u/s 67 B.E. Act and during arrest the ground of arrest was duly notified issuing arrest memo u/s 50 Cr. P.C. and handed over a copy of the same to the arrestee. Out of seized illicit liquor 500 ml taken out in a separate container as sample with sealed & labeled.

The above noted arrested accd Satya Mandi (55 Yrs), S/O- Late Jagran Mandi of Vill- Buribandh, PS - Boro, Dist - Purulia violate section 18(i) B.E. Act. For possession and selling of illicit liquor, not obtained from a licensed vendor and in contravention and he committed offence u/s 46 A (C) B.E. Act. 1909.

It may note here that during raid (1) C/708 Mritunjay Mura, (2) C/ 281 Falguni Patra accompanied me.

Under the fact and circumstanced I therefore pray a case U/S 46 A(C) B.E. Act. 1909 may kindly be started against Satya Mandi (55 Yrs), S/O- Late Jagran Mandi of Vill- Buribandh, PS - Boro, Dist - Purulia.
