I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Rabi Mahato (user) S/O- Binod Mahato of Village- Balarampur, P.O- Kharidwar. P.S.- Boro, Dist - Purulia, has committed theft of Electricity U/S 135(1)(b) of the Electricity (Amendment) Act-2007.

On dated 17.12.2019 at about 4.50 pm, Sri Swarup Manda, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

entered the premises of Rabi Mahato, S/O- Binod Mahato of Village- Balarampur, P.O- Kharidwar, P.S.- Boro, Dist - Purulia and inspected his/her premises and found that he was enjoying electricity unauthorisely i.e. by passing of energy meter from incoming terminal point.

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(b) was detected. It was also found that he/she was using the following electrical equipments -
