In producing here with arrested accused persons namely (1) Somen Mahato (Approx 30 yrs) S/O-Lt. Bhim Mahato of Vill- Bhurkatarh, PS- Jhalda, Dist- Purulia. (2) Jagabandhu@ Jaga Mahato (Approx 50 Yrs) S/O- Lt. Laxminarayan Mahato of Vill- Kansra, PS- Jhalda, Dist- Purulia (3) Tukai Tewari (Approx 20 yrs) S/O- Lt. Sujit Tewari of Jhalda Kumarkuli, Ward No- VI, PS-Jhalda, Dist-Purulia and brought under seizure (1) One iron made improvised country made Two Shooter fire arms and 01 round 8 mm ammunition fitted with butt; body; barrel; firing pin; overall length 24 cm including barrel length 11 cm (2) One iron made Sword, total length approx 80 cm including 10 cm butt (3) One iron made sharp ending punching (Fighter) (4) One iron made SABAL length about 3.5 feet (5) One TABLA total length approx 2.5 feet & width of TABLA approx 13 cm and (6) One Nylon rope about 20 ft. I beg to lodge this complaint to the effect that today (30/11/19) at 22:15 hrs received a credible source information that a gang (Approx 13/14) of dacoits are being assembled at the back side of Marumasina- Bansha High School near Bansha Hill at Bandhdih and are preparing themselves to commit dacoity at nearby houses of local area and tourist vehicles on Jhalda- Ranchi road. I informed this matter to I/C Jhalda PS and noted the fact in GD vide Jhalda PS GDE No- 1157 dated-30/11/19. As per order I SI Nimai Ch Nemo, ASI Bikash Patra, C/386-Shibendu Sinha, C/ 682- Mahadeb Rajak, C/696- Gorapada Pal and NVF 1036- Pramatha Kuiri left for backside of Marumasina- Bansha High School to work out the information with Govt. vehicle WB 56 C/ 8741 vide Jhalda PS GDE No- 1158 dated-30/11/19 and C.C. No-3129/19 dated-30/11/19.

Then, I along with accompanied officers and force reached about 200 meters from the backside of Marumasina- Bansha High School on Jhalda- Ranch road at about 22:55 hrs and kept out vehicle by the side of road in a dark. Then I briefed all officer and force properly and we started to proceed towards back side of Marumasina- Bansha High School near Bansha Hill on foot and when we reached near back side of Marumasina- Bansha High School near Bansha Hill found 14/15 persons sitting in that busy area and whispering each others. Their voice was clearly audible to us due to night & the place was silent zone. They were planning to commit dacoity at nearby houses of local area and tourist vehicles on Jhalda-Ranchi road. After confirmation, we cordoned the area secretly and loudly disclose our identity with a direction to surrender before us. But, all of them tried to run away seeing the police party. However, we managed to apprehend 03 (Three) out of them after a hot chase. Accordingly, I interrogated them thoroughly where they disclosed their identity as-

(1) Somen Mahato (Approx 30 yrs) S/O- Lt. Bhim Mahato of Vill- Bhurkatarh, PS- Jhalda, Dist-Purulia. (2) Jagabandhu Mahato (Approx 50 Yrs) S/O- Lt. Laxminarayan Mahato of Vill- Kansra, PS- Jhalda, Dist-Purulia (3) Tukai Tewari (Approx 20 yrs) S/O- Lt. Sujit Tewari of Jhalda Kumarkuli, Ward No- VI, PS-

Ihalda, Dist-Purulia.

During chase we could identify following accused persons through our search light but they could not be apprehended-

(i) Sk. Abbas of Vill- Kantadih, PS- Jhalda, Dist- Purulia.

(ii) Sk. Imroj @ Moja of Vill- Kantadih, PS- Jhalda, Dist- Purulia.

(iii) Sk. Yasin of Vill- Kantadih, PS- Jhalda, Dist- Purulia.

(iv) Sk. Taimush@ Tarmuj Purano Jhalda, PS- Jhalda, Dist- Purulia.

(v) Dipak@ Rahina Kuiri S/O- Shaktipada Kuiri of Purano Jhalda, PS- Jhalda, Dist-Purulia.

On interrogation of the about noted apprehended persons confessed that they along with above noted accused persons under the leadership of Somen Mahato being armed with Fire arms & deadly weapons were assembled and preparing themselves for committing dacoity at nearby houses of local area and tourist vehicles on Jhalda- Ranchi road. Accordingly, I arrest them maintaining all formalities of arrest, issue memo arrest and informed them the ground of arrest. On search, we recovered and seized the following weapons after preparing proper seizure list & labels duly signed by the witnesses -

(i) One iron made improvised country made Two Shooter fire arms and 01 round 8 mm ammunition fitted with butt; body; barrel; firing pin; overall length 24 cm including barrel length 11 cm which recovered from the exclusive possession of accused Somen Mahato (Kept conceal at the backside of waist) (Fire arms was loaded with ammunition and seized the ammunition after unloading from the fire arms). On being asked whether he have any valid license regarding the above noted arms & ammunitions but he could not produce any valid documents/papers also could not give any satisfactory answer.

(ii) One iron made Sword, total length approx 80 cm including 10 cm butt, (Recovered & seized from the

possession of accused Jagabandhu Mahato).

(iii) One iron made SABAL length about 3.5 feet (Recovered & seized from the possession of accused Tukai Tewari).

(iv) One iron made sharp ending punching (Fighter) from the P.O.

(v) One TABLA total lenth approx 2.5 feet & width of TABLA approx 13 cm

(vi) One Lylon rope about 20 ft. from the P.O.

(vii) Sketch map of Dacoity from the right side pocket of pant of accused Somen Mahato.

I like to note here that due to odd hours of night no public witnesses were available at that time.

Hence, I do here by lodged complaint against the following accused persons namely -

- (5) Sk. Imroj @ Moja of Vill-Kantadih, PS- Jhalda, Dist- Purulia.
- (6) Sk. Yasin of Vill-Kantadih, PS-Jhalda, Dist-Purulia.
- (7) Sk. Taimush@ Tarmuj Purano Jhalda, PS- Jhalda, Dist- Purulia.
- (8) Dipak@ Rahina Kuiri S/O- Shaktipada Kuiri of Purano Jhalda, PS- Jhalda, Dist- Purulia and 05/06 others to start a case against them as they are liable to punish U/S- 399/402 IPC & 25 (1-B)(a)/27/35 Arms Act and arrange for its investigation.
