On 09.12.2019 at about 01.20 P.M. I Sri Nilanjan Kumar Mondal, AE & Station Manager, Joypur CCC along with 01.Ganesh Mahato,Gr1 TSH,Joypur CCC,02.Sristidhar Mahato,HG.TSH,Joypur CCC, entered the premises of Karam chand Majhi, S/O-Lt.Bukhal Majhi of village-Ekduara P.S- Joypur, Dist- Purulia and found Karam chand Majhi, S/O-Lt.Bukhal Majhi was enjoying electricity unauthorizedly drawing power from LTOH Line of WBSEDCL through Al cable Red & Black colour by means direct hooking to his house premises and connected load found 0.2 KW. As Karam chand Majhi, S/O-Lt.Bukhal Majhi, committed theft of electric power.So, I seized the following articles after preparing the seizer list in presence of 01.Ganesh Mahato,Gr1 TSH,Joypur CCC,02.Sristidhar Mahato,HG.TSH,Joypur CCC. The inspection team left the premises at 01.45 P.M.
