Sir,

In producing herewith one arrested accused person namely Thakurdas Paramanik (45 yrs) S/o-Late Khedan Paramanik of Vill-Palanja, PS-Joypur, Dist-Purulia, State-WB under arrest along with seized articles as per seizer list i.e. (1) 13 (Thirteen) bottles Illicit country spirit "DILKHUSH" strength 80 up measuring 600 ML each bottles of Rs. 35/- out of which one bottle taken as sample under proper seizure with label, (2) One plastic jarican, containing 07 liters (approx) of Country Spirit.

I ASI Manoj Kr Das of Joypur PS hereby lodged a written complaint against the above noted arrested accused person to the effect that on today (10/12/2019) at about 19:55 hrs when myself along with JC/-636 Dinesh Duley, JC/-714 Prasenjit Mandal were performed special mobile duty, as per my source information I reached at Forest More under Joypur PS and found that the above noted accused person selling country spirit "DILKHUSH" in his stationary shop. On seeing Police persons, he conceal his presence at that stationary shop, but on searching we able to trace out him and also to found that (1) 13 (Thirteen) bottles Illicit country spirit "DILKHUSH" (2) One plastic jarican, containing 07 liters (approx) of Country Spirit which was kept conceal in a bag in his stationary shop. On being asked he disclosed his name and address as noted above. On interrogation he stated that he was selling Illicit country spirit liquor to the local people in his shop Forest More after collecting from other side but on demand he failed to produce any valid documents in respect of selling such illicit country sprit liquor. So it is reasonable to believe that he was selling the Id liquor illegally without any documents. So I seized the same under proper seizure list in between 20:05 hrs to 20:15 hrs & label duly signed by him and other available witness after taking 01 bottles of DILKHUSH as sample out of 13 bottles of DILKHUSH. During further interrogation he confessed his guilt as such I arrested him today 10/12/2019 at 19:55 hrs as the accused person is liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Thakurdas Paramanik (45 yrs) S/o-Late Khedan Paramanik of Vill-Palanja, PS-Joypur, Dist-Purulia, State-WB U/S-46A (c) of the Bengal Excise Act 1909.
