Sir,

In producing herewith one arrested accused person namely Stalin Das (46 y) S/o-Bhim Das of Vill-Narayanpur, PS-Joypur, Dist-Purulia, State-WB under arrest along with seized articles as per seizer list i.e. 17 (Seventeen) bottles Illicit country spirit "DIL SE" strength 80 up measuring 600 ML each bottles of Rs. 35/- out of which one bottle taken as sample under proper seizure with label.

I SI Susanta Kr Pathak of Joypur PS hereby lodged a written complaint against the above noted arrested accused person to the effect that on today (23/12/2019) at about 17:25 hrs when myself along with JC-725 Rahul Singha Mahapatra, JC-426 Biswajit Banik were performed special mobile duty vide Joypur PS C.C. No-4437/19 Date-23/12/2019, as per my source information I reached at Narayanpur village under Joypur PS and found that the above noted accused person selling country spirit "DIL SE" at his house. On seeing Police persons, he conceal his presence at that shop, but on searching we able to trace out him and also to found that 17 (Seventeen) bottles of Illicit country spirit "DIL SE" which was kept conceal in a bag in his shop. On being asked he disclosed his name and address as noted above. On interrogation he stated that he was selling Illicit country spirit liquor to the local people in Narayanpur village after collecting from other side but on demand he failed to produce any valid documents in respect of selling such illicit country sprit liquor. So it is reasonable to believe that he was selling the Id liquor illegally without any documents. So I seized the same under proper seizure list in between 17:45 hrs to 18.05 hrs & label duly signed by him and other available witness after taking 01 bottles of DIL SE as sample out of 17 bottles of DIL SE. During further interrogation he confessed his guilt as such I arrested him today 23/12/2019 at 18:15 hrs as the accused person is liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Stalin Das (35 y) S/o-Bhim Das of Vill-Narayanpur, PS-Joypur, Dist-Purulia, State-WB, U/S-46A (c) of the Bengal Excise Act 1909.
