



The above named complainant begs to state

as follows:-

1----That your petitioner, the witnesses, and the accused persons are the residents of the same village Nowahatu , under P.S. Kotshila , District Purulia and neighbour to each others .

2----That' some time back the families of the complainant and the families of the accused person became ill due to calling of Witch to the female members of the complainant.

3----That on the date of occurrence at about 11 AM, all the accused person criminally trespassed in the court yard of the complainant and forming an unlawful assembly, encircled the house of the complainant and her inmates . In order to kill the husband of the complainant accused Mihir Gorai gave heavy blow by Farsha on the head of Kashinath Gorai i.e. the husband of your petitioner causing serious bleeding injury . Seeing the Serious bleeding injury of Kashinath Gorai his brother Biswanath Gorai tried to save his elder brother from the clutches of the accused persons then accused Tapan Gorai assaulted Biswanath Gorai with a Iron Rod, on the head of Injured Biswanath Gorai and for that Biswamnath Gorai sustained gravious bleeding injury on his head and fell down, then accused Prafulla Gorai tried to throattle Biswanath Gorai by pressing his neck. Accused Bina Gorai, Hairani Gorai and Purnima Gorai have mercilessly assaulted the complainant, her Dewar Biswanath Gorai and her husband Kashinath Gorai and Jangali Gorai with Bamboo lathi causing injuries on the body of the complainant and her inmates ... Hearing hue and cry the some villagers reached the place of occurrence seeing those persons the accused persons hurriedly leave the place and threatened the complainant and her family members to murder them .

4----That there after ,by the help of the villagers the injured persons were taken to Kotshila Police Staion . The petitioner, the injured persons and the P.W.s narrated the incident to the police officer who sent the injured persons to Kotshila Hospital for treatment . The Doctor of Kotshila Hospital seeing the Critical condition of the injured persons immediately referred them to Purulia Sadar Hospital where the injured were treated for 3 /4 days as indoor patient On further approach to police, your petitioner came to learnt that till yet no specific case whatsoever has been started against the accused person. Under such circumstances, your petitioner finding no other alternative







but to knocked the door of the Superintendant of Police Purulia on 18-10--2019, but nothing has been done from his good office.

5----That your petitioner is a very poor woman . She is helpless having no source of in come whatsoever . She is not in a position to conduct the case on her own expense . Moreover , there are some technical and legal aspects involved in this case which also requires considerable money and machinery . For all these , it is highly desirable that this case should be converted to a police case for thorough Police investigation.

It is prayed that your Honour may be graciously

Pleased to direct the Officer –In Charge Kotshila Police Station to investigate the case in accordance with law, treating the same as F.I.R., as contemplated U/S 156(3) Cr.P.C.
