Sub: Complaint against Buka Singh Mura (44 years), S/O- Late Nutu Singh Mura of Vill- Chatambari, PO- Begunkudar PS - Kotshila, Dist - Purulia to start a case U/S- 46A(C) B.E. Act 1909.

Respected Sir,

In producing herewith one arrested accd. Buka Singh Mura (44 years), S/O- Late Nutu Singh Mura of Vill- Chatambari, PO- Begunkudar PS - Kotshila, Dist - Purulia with seizure of approx 20 liters illicit spirit, from the possession of above noted accused which was seized under proper seizure list.

I beg to submit that today (23.12.19) during Special raid duty in between 17:55 hrs to 18:25 hrs on acting a secret source information I held raid at the House of above noted person at Chatambari. He has sealing illicit spirit at his house .I search at his house and found approx Twenty(20)Liter illicit spirit which was kept in a yellow colour jaricane. On interrogation he disclosed his name and address as noted above. On demand he failed to produced any valid documents in respect of illicit spirit which is kept in Jaricale containing approx 20 litters. Accordingly I seized the same under proper seizure list in presence of witnesses, u/s 67 A (C) B.E. Act which is enclosed herewith. As such he was arrested at 18.25 hrs u/s 67 B.E. Act and during arrest the ground of arrest were duly notified issuing arrest memo u/s 50 Cr. P.C. and handed over a copy of the same to arrestee. Out of seized illicit liquor One(01)liter taken out in a separate container as sample with sealed & labeled.

The above noted arrested accd Buka Singh Mura (44 years), S/O- Late Nutu Singh Mura of Vill- Chatambari, PO- Begunkudar PS - Kotshila, Dist - Purulia violate section 18(i) B.E. Act, for possession and shelling of intoxicating not obtained from a licensed vendor and in contravention and he Committed offence u/s 46 A (C) B.E. Act 1909.

It may note here that during raid (1) C/424 Naba Kr. Sao (2) C/138 Bari Bandopadhyay accompanied me Vide Kotshila P.S.C.C No- 3484/19, Dated 23.12.19

Under the fact and circumstanced I therefore pray a case u/s 46 A (C) B.E. Act 1909 may kindly be started against Buka Singh Mura (44 years), S/O- Late Nutu Singh Mura of Vill- Chatambari, PO- Begunkudar PS - Kotshila, Dist - Purulia.
