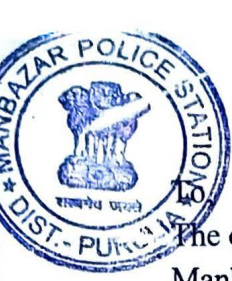

Sir,

In producing here with one accused person Sachin Hansda (39yrs) S/O Lt Sarat Chandra Hansda of village- Patharkhunja, PO- Pedda PS- Manbazar, Dist- Purulia along with following seized articles viz-

- (1) 15 (fifteen) Ltrs ID liquor within a Jarikan
- (2) 12 pieces plastic glass
- (3) Sale proceed of Rs- 115/-

I AS.I. Chittaranjan Mukhopadhyay of Manbazar PS do here by lodged a complaint against accused namely Sachin Hansda (39yrs) S/O Lt Sarat Chandra Hansda of village- Patharkhunja, PO- Pedda PS- Manbazar, Dist- Purulia to the effect that today (30.11.19) at 17:05 hrs. I received a telephonic information from a reliable source that one Sachin Hansda (39) S/O Lt Sarat Chandra Hansda of village- Patharkhunja, PO- Pedda PS- Manbazar, Dist- Purulia has stocked ID liquor illegally and selling the same after hike price for his personal gain. I noted this information in GDE vide Manbazar PS GDE No- 1158 Dtd 30.11.19. I informed the matter to O/C Manbazar PS and as per order of O/C Manbazar PS myself along with C/1211 Chunaram Hambram, NVF/537 Asit Mahato rushed to the spot for conducting raid by Govt. vehicle. At about 17:45 hrs myself along with force reached at Patharkhunja village and held raid at the house of Sachin Hansda and found that said house owner selling ID liquor in his own house. Seeing the Police party some persons fled away and said Sachin Hansda tried to concealed himself but we are able to apprehend him and also detained him. I asked him to produce valid license or valid papers for selling ID liquor, but he failed to produce any valid license or documents for possessing / selling the same. So I arrested the above noted accused person informing the ground of arrest and seized the above mentioned articles after proper seizure list duly sign by accused person and available witnesses.

Hence, I therefore pray that a specific case may kindly be started against arrested accused person Sachin Hansda (39) S/O Lt Sarat Chandra Hansda of village- Patharkhunja, PO- Pedda PS- Manbazar, Dist- Purulia as per law and arrange for its investigation.
