Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one accd. person namely Pandab Bauri @ Panda (27) S/O- Nibaran Bauri of Vill-Naragoria, PS-Neturia, District- Purulia with seizure of 17 pcs. Sealed bottles of Dil Se country spirit containing 375 ml each which were seized under proper seizure list.

I beg to submit that today (10.12.19) at 18:05 hrs while myself, ASI Sujoy Kundu, with force were performing anticrime evening mobile duty near Haridih More that time received a source information that one Pandab Bauri @ Panda (27) S/O- Nibaran Bauri of Vill-Naragoria, PS-Neturia, District- Purulia has illegally stocked liquor in his Chop/Pakori shop at Naragoria village under PS- Neturia & selling the same. On receiving the information, I informed the matter to you and as per your instruction, I along with force proceeded to Naragoria village to work out the information. At 19:05 hrs after reaching at Naragoria village held raid in the shop of Pandab Bauri @ Panda and found that he was keeping / selling liquor which were kept in his shop, on demand Pandab Bauri @ Panda failed to produce any valid documents/License in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A (c) B.E. Act and he was arrested U/S-67 BE Act and also 17 pcs. Sealed bottles of Dil Se country spirit containing 375 ml. each which were seized under proper seizure list duly signed by witnesses and labeled. During arrest the ground of arrest was duly notified, issued arrest memo u/s 50 Cr. P.C. and handed a copy of the same to arrestee.

The arrested accd. namely Pandab Bauri @ Panda (27) S/O- Nibaran Bauri of Vill-Naragoria, PS-Neturia, District- Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid (1) C/1140 Dayamoy Mahato (2) C/1260 Santosh Soren and (3) C/470 Somnath Nag all are of Neturia PS accompanied me.

Under the above facts and circumstances I therefore pray that a specific case may kindly be started against Pandab Bauri @ Panda (27) S/O- Nibaran Bauri of Vill-Naragoria, PS-Neturia, District- Purulia u/s- 46 A(c) B.E.
