To The Officer In-Charge, Para P.S. District - Purulia,

Respected Sir.

In producing herewith one arrested acod, person namely Pelu Rajwar (42yrs) S/O - Lt. Ganu Rajwar of Village- Raherdih, PS- Para, Dist. Purulia with seized article i.e 19 (Nineteen) pcs sealed bottles of Country Spirit styled as "DIL KHUSH" each Bottle contains 600 ml in which 01 (one) bottle as sample which were seized under proper seizure list.

I beg to submit that today (10.12.19) during my Spl. raid duty in between 17.15 hrs to 17.35 hrs acting on a tip off a raid was conducted in the house of Pelu Rajwar (42yrs) S/O - Lt. Ganu Rajwar of Village-Raherdih, PS- Para, Dist. Purulia and found that the above noted person was keeping and selling Country Spirit which were kept in his house. On demand he failed to produce any valid document in respect of keeping and selling of said liquors. As such I seized 19 (Nineteen) pcs sealed bottles of Country Spirit styled as "DIL KHUSH" each Bottle contains 600 ml under proper seizure list in presence of witnesses duly signed by them and also arrested the above noted accid. person. During arrest maintain all rules and norms as well as guideline of NHRC/WBHRC and also informed his family member.

The above noted arrested accd, namely Pelu Rajwar S/O - Lt. Ganu Rajwar of Village- Raherdih, PS- Para, Dist. Purulia committed offence u/s 46 A(c) B.E. Act. 1909 for unauthorized possession and sale of said liquors.

Under the above fact and circumstance I therefore pray that a case u/s 46 A (c) B.E. Act'1909 may kindly be started against Pelu Rajwar S/O - Lt. Ganu Rajwar of Village-Raherdih, PS- Para, Dist. Purulia and arrange for its investigation.
