During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by direct tapping from incising side of service cable.

Supply i.e. U/S 135 was detected.

From the above system he/she was using the following Electrical equipments i.e.

- 1) 100 watt bulb - 2 NOS
- 2) TV - 2 NOS (140 watt)
- 3) 4 NOS - FAN (120 watt)
- 4) Fridge - 1 NO (180 watt) [Total Load - 1.54 kW]

Out of which we seized the following:

- 2) Service cable - 1m (Approx)
- 3) 100 watt bulb - 2 NOS
