**Sub: - F.I.R. against Samuel Ansary S/O- Rewaz Ansary of VIII- Tetulhity, P.O.-P.S.-Para, Dist -Purulia against theft of electricity.**

Dear Sir,

I do hereby lodge a complaint being empowered by the Electricity Act, 2003 to the effect that **Samual Ansary S/O- Rewaz Ansary of Village-Tetulhity, P.S.-PARA, Dist-Purulia**, the user of the electric has committed an offence of theft of electricity under section 135 (1) (a) of Electricity Act, 2003 read with amendment of Electricity Act, 2007.

On 13.12.2019 at about 04.12PM, I GOUTAM KUMAR MANDAL, SM of DUBRA PARA C.C.C, along with Gourab Dasgupta DE(ESTB) of Dubra Para CCC, Alok Kumar Pandey of Dubra Para CCC, Alok kumar Pandey Gr.-I TSH and other staffs of Dubra Para CCC, WBSEDCL inspected the premises of **Samual Ansary S/O- Rewaz Ansary of Village- Tetulhity, P.S.-Para, Dist -Purulia WBSEDCL**. During inspection it was found that the said **Samual Ansary** was enjoying electricity unauthorizedly by direct tapping of service cable as hooking arrangement from WBSEDCL's nearest low tension over head line for running his 1 no 100watt bulb, and 01 no fan, approx load 0.180KW for domestic purpose, which is an offence u/s. 135 (1)(a) of Electricity Act, 2003 read with the amendment of Electricity Act, 2007.

As electricity theft was detected, his service line has been disconnected and seized as token and labeled by preparing Seizure list at site. Due to theft of electricity a loss of revenue was incurred to the WBSEDCL. The inspection team left the site at about 04.29 PM.

As such **Samual Ansary S/O- Rewaz Ansary of Village-Tetulhity, P.S.-PARA, Dist- Purulia** has committed an offence of theft of electricity under section 135 (1)(a) of Electricity Act, 2003 read with amendment of Electricity Act, 2007. So, you are requested to take cognizance of this offence of theft of electricity treating this complaint as F.I.R.
