

The Complainant above named

Most respectfully begs to state:

- 1. That the Complainant is the legally married wife of the Accused Person No.1 and the Accused Person No. 2, 3 & 4 are the brothers-in-law, Accused No.5 & 6 are the parent's-in-law, Accused No.7 is the sister-in-law, Accused No.8 is a near relative of Accused No.1 to 7 and the Accused Person No.9 is the aunt-in-law of the Complainant. The Accused Person No. 9 is living at the matrimonial home of the Complainant.
- 2. That the marriage of the Complainant was solemnized on 19 /02/2010 with the Accused Person No.1 as per Muslim Shariyat Law prevailing in their society at the paternal house of the Complainant at Joypur, P.O.& P.S.-Joypur, District-Purulia. At the time of marriage the father of the Complainant by way of dowry gave cash, ornaments, furnitures and utensils as per demand of the Accused Persons amounting to Rs.3,00,000/-.
- 3. That after the marriage the Complainant went to her matrimonial home at Digudi Para, Purulia, Purulia Municipality Ward No.8, within P.S.-Purulia(T), District-Purulia and residing therein.
- 4. That since after the marriage the Accused Persons started to ill-behave and ill-treat the Complainant. The husband of the Complainant off and on started to torture the Complainant both mentally and physically and he also instigated others to ill-treat the Complainant. The Accused person No.9 is residing with the Accused No.6 being her sister and she along with Accused No.8 also illtreat and torture the Complainant. The Accused No.3, 4 & 7 did not give respect to the Complainant and they at the instigation of other Accused Persons always abused her off and on.
- 5. That the Complainant bears all such torture with a hope that in future the Accused Persons shall mend their behavior but her all such expectation went in vain.
- 6. That when such state of things were going on the Complainant gave birth of two childs, one female and one male child.
- 7. That the female child named as Ruksar Khatun and since after her birth the torture upon the Complainant increased a lot.
- 8. That the Accused Persons demanded a further amount of dowry of Rs.50,000/-from the father of the Complainant. The Complainant informed the matter to her parents but her father replied them that it is not possible for him to fulfill such further demand as he is a poor person.
- 9. That since thereafter the torture upon the Complainant increased both mentally and physically and during those days she was deprived from two square meals. She was residing with her childs outside of the room. The Complainant had to do all the household work from dawn to late night.
- 10. That when such state of things were going on the Accused Persons on a day in the year 2017 at about 8 PM, by hatching up a conspiracy after assaulting the Complainant, poured kerosene oil over her body, so as to burn her alive, but she somehow managed to escape.





- 11. That thereafter after several settlements the Accused Persons took the Complainant & her childs to the matrimonial home with an undertaking to keep her properly.
- 12. That after few days the Accused Persons again started to ill treat & torture the Complainant without any reason. The Complainant bore all such torture with a hope in near future the Accused Persons would mend their behavior but her such expectations went in vain.
- 13. That when such state of things were going on, the Accused Persons after assaulting the Complainant mercilessly tried to kill her by putting her under a pillow on 02/12/208 in the late night and after some time they left there thinking that the Complainant is dead.
- 14. That after few times the Complainant regained consciousness and at about 1.30 AM she left the matrimonial home with the childrens to save her life. On the next morning the Complainant somehow reached Joypur in her paternal house and intimates her parents & others about the matter.
- 15. That at present the Complainant being a helpless lady is residing with her father along with her minor daughter & son and the Accused Persons do not want to keep them at the matrimonial home.
- 16 That thereafter the parents of the Complainant & some other persons went to the matrimonial home of the Complainant with a request to keep the Complainant at their house and tried to solve the matter but the Accused Persons abused them and ousted from their house.
- 17. That the Complainant informed the matter to the O/C Purulia(T) P.S. requesting him to take legal steps against the Accused Persons but the police did not take any action in the matter up-till now.
- 18. That the Complainant also informed the matter to the S.P. Purulia on 30/09/2019 but up-till now no action has been taken by the police.
- 19. That thus the Complainant brought this case for the offences committed by the Accused Persons for which they are liable to be prosecuted.

It is therefore prayed that your honour may graciously be pleased to treat this petition as a Complaint under Section-156(3) of the Cr.P.C. & send the petition to the O/C Purulia(T) P.S. for investigation & further be pleased to pass necessary order.
