



- 2... That at the time of marriage my poor father had to pay a cash of Rs.3,00,000/-(Rupees Three lakh) along with golden brnaments and other valuable articles as per their demand.
- 3... That after marriage while I stepped into my matrimonial house as a newly weded wife and started my matrimonial journey in ususal manner I, to my utter surprise noticed some unusal behaviour towards me by the accused persons but initially I managed the same.
- 4. That incourse of my residing at my matrimonial house while I was residing with my husband along with other inmates of my family I was blessed with a son



That in course of my res stay at my matrimonial house all the accused persons without any of my lapses abused me in filthy languages by all the accused persons, my sister-in-law and her husband i.e. Accused nos. 4 & 5 are residing within Purulia(T) P.S. but both of them regular visit at my matrrimonial house and in course thereof all the accused persons made a some plan behind my back gradually all the accused persons started all sorts of inhuman physical as well as mental tortured upon me which became persisting tortured passing of time became unbearable to me. They all not providing me fooding .Clothing even not provided to food to the son of the petitioner and other bear necessities.

Hower bearing all such tortured the petitioner some how continued to stay at her matrimonial house for a good days which in my opinion would come. But incourse thereof the accused persons was mend their mind.

6. That thereafter all the accused persons asked me to kring further bring of Rs. 50,000/- from my father as Additional dowery but my poor father due

In such circumstances the complainant along with my ba laping baby to save our life returned wack at my matrimonail hosue . And since there I along my minor residing at Purulia Town .

7...That meanwhile my husband the accused no 1 had contracted 2nd marriage with one Sanu Karmakar at Village Garbatha within District Paschim Midnapur during subsisting of our marriage .And the other accused persons directly abated/intigated the said marriage and they were present at that time.

That while the complainant is residing at her paternal beare house all the accused persons with the help of instigation of accused no.4 & 5 came at my paternal house and started to abuse my/us in failthy and languages & tried to snatch my minor son and also slapped me in presence of me out when we raised alaram the neighbour people came there then they fled away.
