



That the complainant most respectfully beg to state as follows:-

1. that the complainant is the resident of Hadla Chak, Barhira, P.O.- Cheliyama, P.S.- Raghunathpur, Dist.- Purulia West Bengal and the incident took place within the jurisdiction of your ld. Court.
2. that on 18/04/2019 at about 8.30 A.M. while the complainant was going to his shop, on and sudden , in front of the SSK School, the accused namely MAMTAJ ANSARY throw acid upon the complainant, for which he sustain grevious hurt to the left hand and face and at that moment,



the other accused persons namely JARINA BIBI, HADIS ANSARY, SIDDIK ANSARY, FIROJ ANSARY, HUSSAIN ANSARY and SAHINA KHATUN instigate MUMTAJ ANSARY by saying "JAMIR ANSAY KE MERE FELE DE" and surrounded the complainant to restrain him and throwing the acid upon the complainant. And hearing the hue and cry of the complainant, the near by people namely SUKUR ANSARY, ME. HUSSAIN ANSARY , YUSUF ANSARY , SULEMAN ANSARY and SARIF ANSARY tried to rescue the complainant and save him. And took the complainant to BANDA BPHC hospital for treatment.

3. That the complainant after regaining his health went to Raghunathpur P.S. to lodged the complaint, but the concern P.S. has not received the complaint, and advice the complainant to take shelter of Id. Court.
4. That being dissatisfied, the complainant made a application before the S.P., Purulia, dated 16/09/2019, with copy to I/C Raghunathpur P.S. about the incident vide registered letter dated 16/09/2019, but till to-day there is no any fruitful result.
5. That the complainant has sustain grevious hurt by the use of act by the above named accused person having burn in person due to common intention and object of the above named accused person.
6. That finding no other alternative, the complainant have to take shelter before the Id. Court for the redressal of her grievance.

It is therefore prayed before the Id. Court may kindly allow this petition treating the same U/S 156(3) of Cr.P.C. , and to pass necessary order/orders , direction/directions, to the Inspector In Charge, Raghunathpur Police Station to treat the same as F.I.R. against the above named accused persons and any other order/orders, direction/directions , as your Id. Court may deem fit and proper for the ends of Justice. And for this act of kindness the complainant shall ever prays.
