Respected Sir,

I Hemant Kumar Singh S/o Late Arvind Kumar Singh, Address: H No 12, Zone 1 B, Po/Ps- Birsanagar Jamshedpur 831004, would like to inform you that on 27/11/2019 at about 23:30 hrs. While my brother-in-law Niraj Kumar Singh, S/o Late Gopal Prasad Singh, and 2 (two) others were proceeding towards Jamshedpur by one white vehicle (Hyundai Eon having Reg. No JH05AN- 8366) from Sultanganj, Bihar and when they reached there near Nutundih Morh Under Rahunathpur P/S, Dist- Purulia at that time one Truck having Reg. No WB39B-6727 dashed into vehicle of Niraj Kumar Singh Hyundai Eon having Reg. No JH05AN- 8366, which was coming from opposite direction . As a result Niraj Kumar Singh and 2 (Two) others sustained bleeding injuries and after that they have been shifted to Raghunathpur S.S. Hospital and from there referred them to TATA MAIN HOSPITAL Jamshedpur for better treatment. The details of injured persons are (1) Niraj Kumar Singh (40 Years) S/o Late Gopal Prasad Singh. Add: Q. No. – 24B, West Road Cross Govind Nagar, Uliyan Kadma Jamshedpur 831005. (2) P. Rama Krishnan (45 Years), S/o R. Parsuram (3) Prakash Roy (45 Years) S/o Asarfy Rai.

The vehicle having Reg. No- JH05AN-8366 (Hundai Eon Car) was fully damaged in this incident. The incident happened due to rash and negligent driving of driver of vehicle Reg. No – WB39B- 6727 (Truck).

Therefore I pray before your kind honor that necessary steps may kindly taken against the driver of offending vehicle (Truck) having Reg. No - WB39B- 6727.

Delay for lodging FIR was because I was busy in the treatment of the injured persons above mentioned.
