It is to intimate that on 28.11.2019 at about 07.00 hrs a coal truck bearing Registration No WB 53B (5875) of OSL Pvt Ltd. has reported to the Naragoria Gate/Coal Gate for exit of the plant after weighing & unloading of coal. On checking of the vehicle by the CISF duty personnel CT/GD Julfikar SK Md. who are deployed at the said gate and found that 700 kg of coal which were trying to take out of the plant DVC, RTPS unauthorizedly by the said vehicle. After detection of unauthorized coal, the driver fled away leaving the vehicle at the gate.

In view of the above, it is requested you to kindly register an FIR against the driver of vehicle (Lorry) having Registration No. WB 53 B 5875 and necessary action may be taken please.
