Sub : Prayer for lodging FIR against accused Maqbul Khan (53), S/O - Lt. Gulam Roshan Khan of Kankibazar, PS-Santaldih Dist- Purulia U/S 46A (c) B.E. Act 1909.

Sir,

In producing herewith arrested accused Maqbul Khan (53), S/O - Lt. Gulam Roshan Khan of Kankibazar, PS-Santaldih Dist- Purulia along with seizure - list and seized items as described below, I beg to state that on 19.12.2019 at about 19:15 hrs I, SI Sourav Kanti Das of Santaldih PS received a source information to the effect that the country liquor have been kept and selling at "**kancha thek**" Kankibazar - Beko colony of above noted accused illegally with an object to sale . I convey the matter to duty officer ASI Dolon Das over telephone. He has diarized the information under Santaldih P.S. GDE No-806, dated- 19.12.2019 and as per order of I.C Santaldih P.S. I along with force left for Kankibazar -Beko colony to work out the information with the govt. supplied kits box containing white cloth, sealing wax, seal, papers, carbons, candles etc. I had been to the "**Kancha thek**" at Kankibazar - Beko colony at about 19:45 hours. Seeing police, some unknown persons fled away in front of the "**kancha thek**" at Kankibazar - Beko colony.

However, I could detain one among them and asked about his identity. He revealed his name and identify as above and as well as informed also that he gather the country spirit for selling and he was the owner of the "**Kancha thek**". However, I along with said accd. started a search inside the "**Kancha thek**" and found the following item in the said "**Kancha thek**".

(1) 04 (Four) bottles 80UP country spirit (Dil khus) each bottles containing 600 ML market value of each being in total approx Rs. 140/ - (One hundred forty only),

01 (one) bottle of 600 ML taken out of the above as sample packet, labeled and sealed with sealing wax.

(2) Cash Rs. 180/- (One hundred eighty) as sale proceed.

I, interrogated him about the purpose of the stocking and possessing of the liquor said to be country spirit. He replied it was the business of him. On repeated question he told that the persons who fled away were his customers (names of those not known to him). However he could not show any documents/papers in support of the possession as well as sale of the said articles.

As such, I seized the above items as ALAMAT under proper Seizure List between 20:15 hrs to 20:45 hrs & took up one bottle as samples, labeled and sealed accordingly.

Since the allegation against him of possessing, the C.S illegally without any valid papers for the purpose of selling in his "**kancha thek**" has prima-facie been made out and for the interest of proper investigation. I arrested the above accused at 20:05hrs accordingly.

Therefore, I pray before you to start a case under proper section of law against the accused Maqbul Khan (53), S/O - Lt. Gulam Roshan Khan of Kankibazar, PS-Santaldih Dist- Purulia.
