Dear Sir

I do hereby lodge a complaint being empowered by the Electricity Act. 2003 to the effect that **Ashok Kumar Mahato**, S/O- Lagnu Mahato of VILL- ANANTAPUR (Dumurdih), P.S.-Santalidih, Dist-Purulia, the user of the electric has committed an offence of theft of electricity under section 135 (1) (A) of Electricity Act. 2003 read with amendment of Electricity Act. 2007.

On 06.12.2019 at about 10:10AM, I GOUTAM KUMAR MANDAL, SM of DUBRA PARA C.C.C, along with, Mr. Patit Kora, Hg TSH, Mr Bhaktipada Mahato, TSH, Mr. Nimai Chandra Mahato, TSH, Dubra Para CCC inspected the premises of Ashok Kumar Mahato, S/O-Late Lagnu Mahato of Village-ANANTAPUR (Dumurdih), P.S.-Para, Dist-Purulia WBSEDCL. During inspection and it was found that the said **Ashok Kumar Mahato** was enjoying electricity unauthorized by direct hooking arrangement from WBSEDCL's nearest low tension over head line for running his 01no CFL-23watts, 02 nos table fans, each of 65watt, 04nos LED each of 9watt. approx load 0.189KW for domestic purpose, which is an offence u/s. 135 (1)(A) of Electricity Act. 2003 read with the amendment of Electricity Act. 2007.

As electricity theft was detected, his service line has been disconnected and seized as token and labeled by preparing Seizure list at site. Due to theft of electricity a loss of revenue was incurred to the WBSEDCL. The inspection team left the site at about 10:25AM.

As such **Ashok Kumar Mahato**, S/O- Lagnu Mahato of VILL- ANANTAPUR (Dumurdih), P.S.-Santalidih, Dist- Purulia has committed an offence of theft of electricity under section 135 (1)(A) of Electricity Act. 2003 read with amendment of Electricity Act. 2007. So, you are requested to take cognizance of this offence of theft of electricity treating this complaint as F.I.R.
