

Sub: Complaint against Bomnath Mukherjee (25Yrs) S/O - Tarapada Mukherjee, of Vill -Mokra, PS-Santuri, Dist - Purulia, to start a cog case U/S- 46A(C) B.E. Act 1909.

Respected Sir,

I SI Gopal Chandra Man S/O- Sri Dhirendra Nath Man of Vill-Gopinathpur, PS-Beliatore, Dist-Bankura now posted at your P.S in producing here with the arrested accused person namely Bomnath Mukherjee (25Yrs) S/O - Tarapada Mukherjee of Vill -Mokra, PS-Santuri, Dist - Purulia, along with 15 liters 600 ml Country Spirit (26 bottle X 600ml) value of Rs- 35 X 26 = 910/- seized under proper seizure list, I beg to submit that today I along with force while performing evening mobile duty at about 20:05 hrs received a credible source information that one person namely Bomnath Mukherjee (25Yrs) S/O -Tarapada Mukherjee of Vill -Mokra, PS-Santuri, Dist - Purulia, is stocking and selling Country Spirit without any valid license from his dwelling house at Mokra village, P.S - Santuri, Dist - Purulia. Accordingly, I along with force had been to the spot at Mokra village to work out the source information and held raid into the premises of above mentioned alleged person. While we reached near to the dwelling house of him then seeing the Police personnel, customers were fled away. During search with the help of my accompanying force, we found that the said person is stocking bulk amount of Country Spirit bottles for sale. On demand, he failed to produce any valid documents/ License in respect of selling and keeping of Country Spirit bottles. Accordingly, I arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act 1909 and supply one copy to him. Then, I seized and labeled 26 (twenty-six) bottle "DIL SE" country spirit containing 600ml each bottle and amounting Rs-35/- (Thirty five) each bottle, Total amounting Rs--910/- under proper seizure list duly signed by the witnesses. From the seized bottles one bottle is sealed and labeled as sample.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(C) B.E. Act 1909 against the arrested accused person namely Bomnath Mukherjee (25Yrs) S/O -Tarapada Mukherjee of Vill -Mokra, PS-Santuri, Dist – Purulia, and arrange for its investigation.
